LIABILITY AGREEMENT

Client Agreement and Release of Liability

I hereby release Dogone Fun, Inc., its agents, officers, sub-contractors, employees, animal owners, customers, and potential customers of Dogone Fun, Inc. from any and all liabilities, financial, and otherwise, for injuries to myself, my dog, or any other property of mine, which arise in any way from services and/or products provided by or as a consequence of my association with Dogone Fun, Inc.

I agree to assume all liabilities and responsibilities, financial and otherwise, for the behavior and health of my dog. In consideration of the services rendered by Dogone Fun, Inc., I waive any and all claims, actions, or demands of any nature, foreseen or unforeseen, that I may have against Dogone Fun, Inc. relating to the care, control, health, and/or safety of my dog arising during pick-up, transport, drop-off, and stay at the facilities.

I authorize Dogone Fun, Inc. to do whatever they deem necessary for the safety, health, and well-being of my dog while under the care of Dogone Fun, Inc., including seeking professional veterinary treatment for my dog.

Due to the many outstanding benefits of dog socialization and Dogone Fun, Inc.'s commitment to the safety and well-being of my dog, I agree that the benefits of dog socialization outweigh the risks. Furthermore, I request a socialized environment for my dog while under the care of Dogone Fun, Inc.

I understand that Dogone Fun, Inc. has the right to refuse service to me and/or my dog at any time for any reason. I understand that if my dog has a history of or repeatedly demonstrates aggression or biting of humans or animals, Dogone Fun, Inc. reserves the right to refuse service. I understand that all bites will be reported to the local authorities as required by law.

I hereby declare to Dogone Fun, Inc. that I am the legal owner of my dog; that my dog has not been exposed to distemper, rabies, or parvovirus within the past thirty (30) days, that my dog has been inoculated as indicated by records presented.

Payment Requirements

I understand that the hours of operation at Dogone Fun, Inc. are 7 a.m.-7 p.m. Monday-Friday and 9 a.m.-4 p.m. Saturday. A \$5/hour late fee applies after 7 p.m. until 10 p.m. to be paid in cash upon arrival. If I have not picked up my dog by 10 p.m. Dogone Fun, Inc. will board my dog overnight at my expense. Should this take place, I authorize in advance that Dogone Fun, Inc. will automatically charge my credit card a \$15 late fee, and a \$35 boarding fee, totaling \$50.

If I purchase a half-day service and fail to pick up my dog after six (6) hours, I will be charged the full-day fee of \$25. If I fail to pick up my dog by 7 p.m., I understand that a late fee and boarding fee will be assessed at the rates listed above.

I authorize Dogone Fun, Inc. to charge my credit card for any outstanding balance on my account. I understand that I will be charged a \$25 handling fee for returned checks.

Grooming Details

I have given specific grooming information about my dog to Dogone Fun, inc. and understand, that if Dogone Fun, inc. requires any clarification of my grooming requests they will not groom my dog until they contact me.

I understand that the dematting procedure increases the risk of injury to my dog and will not hold Dogone Fun, Inc., it's owners or it's employees responsible for injury or medical expenses resulting from my dog being dematted. I understand that my dog will only be dematted at my request.

By signing below, I acknowledge that I have read this Daycare & Boarding Agreement in its entirety and agree to the terms. This agreement shall be binding for a period of ten (10) years from the date of signature below.
